## **Basic Data Protection Information**

## **2. Personal data processed by Room Mate: purposes and legitimacy**

You are hereby informed that all the data that Room Mate requests or may request is necessary for the purposes described in this privacy policy and not providing this will result in it being impossible to contact you or manage the request made to Room Mate. Likewise, Room Mate reserves the right to not respond to or process requests that do not include the data that had been requested.

You guarantee the veracity of the personal data provided to Room Mate. Room Mate can periodically request the review and updating of your personal data that it retains.

On the Website you can find the information that may be of use with regards to informing yourself about the services offered by Room Mate. In this regard, Room Mate will only request and process the data necessary to process the query made, provide the service contracted or to be able to start and maintain a commercial, contractual and/or pre-contractual relationship with you.

Below, the different purposes for which your personal details are processed and the basis that legitimizes that processing is described.

### ***i. Legitimacy through the execution of a services contract between you and Room Mate or the application of pre-contractual measures.***

- a. To manage the bookings made by Room Mate's clients through the Website, which includes managing the queries it receives from said clients and the monitoring of the relationship maintained.
- b. To manage the relationship with the different users of the Room Mate Website, attending to their requests and monitoring the relationship maintained.

### ***ii. Legitimacy through legitimate interest:***

- a. To statistically measure the reason for which our clients visit us. For this, we will only request the reason for the booking made. Our legitimate interest in carrying out said processing lies in improving our commercial offerings. Room Mate will process the data for the purposes indicated whilst evaluating the findings resulting from the statistical analysis undertaken.
- b. To undertake statistics, studies and analysis of our clients, for which we carry out a commercial profiling based on the interested party's surfing habits, consumption and preferences shown during the stay at our hotel and/or use of our services. Our legitimate interest in undertaking said processing lies in improving our commercial offerings and an improved knowledge and continual improvement of our business. Room Mate will process the data for the purposes indicated whilst evaluating the findings resulting from the statistics, studies and analysis undertaken.
- c. To grant data to the other Companies in the ROOM MATE Group, as a result of the centralization of the administrative and computer processes that exist within the ROOM MATE Group. Room Mate will process the data for the purpose indicated whilst undertaking the corresponding administrative and computer processes.

### **iii. Legitimacy through express consent:**

- a. Should you authorize this, the sending of advertising and commercial information related to the different businesses of the Group that Room Mate belongs to, its activities, products, services, offers, special promotions, as well as documentation of a diverse nature through any means, including electronically, as well as undertaking the profiling of your consumption habits by means of internal and external information, with the aim of offering you special offers on products or services that are adjusted to your needs.
- b. Should you authorize this, the granting of data to third party companies and advertising partners of Room Mate, including the businesses in the Group that Room Mate belongs to, with the aim of sending you commercial communications related to the sector of activity of each of these adjusted to your needs, through any means, including electronically.
- c. Should you authorize this, registration on the form enabled for the subscription to job offers, as well as, if appropriate, the subsequent monitoring of the candidacy presented.
- d. Should you authorize this, to manage the subscription and/or unsubscribing to the Newsletter.
- e. Should you authorize this, to manage the subscription and/or unsubscribing to the Happitality club newsletters.
- f. Should you authorize this, to manage the contact and quote requests, as well as the requests for information via the Events form available on the Website, in addition to any other form that may be enabled on this.
- g. Should you authorize this, to manage your data to take part in competitions, raffles and similar promotions. In case of conflict between the conditions of the promotion and this Privacy Policy, the conditions of the promotion will prevail.

#### **4. Data Security**

Room Mate has suitable policies and technical and organizational measures in order to safeguard and protect your personal data against illegal or non-authorized access, loss or accidental destruction, damage and illegal or non-authorized use and dissemination.

We will also take all reasonable precautions to guarantee that our staff and employees that have access to your personal data have received the appropriate training.

#### **5. Data Storage**

The term for storing your data will be determined with regard to the length of your relationship with Room Mate and the legally established periods. In this regard, the criterion that Room Mate uses to establish the data storage terms have been determined pursuant to the requirements established in the legislation, regulations and policy guidelines applicable, as well as Room Mate's operational requirements related to the correct management of the relationship that exists with the different categories of interested parties.

Once this has terminated, the process of deleting your personal data will begin at the moment in which all the actions that are necessary to manage and conclude any obligation that main remain between the parties have been undertaken. Without prejudice of the above, your data will be stored duly locked, whilst responsibilities regarding the execution of our contractual or pre-contractual relationship may ensue, as well as for the fulfillment of other legal obligations that Room Mate has.

In this regard, Room Mate guarantees that it will not process data unless it is necessary for the formulation, exercise or defense of claims or when it is required to provide said data to the Public Administration, Judges and Courts during the period of limitation of its rights or legal obligations.
